



2020 Annual Giving Scholarship

St Mary's Anglican Girls' School is an independent day and boarding school for girls from Kindergarten to Year 12. We are renowned for our high level of academic achievement and encouraging a love of learning in a Christian environment.

St Mary's Anglican Girls' School invites applications for the Annual Giving Scholarship for a girl who is beginning Year 7, 8, 9 or 10 in 2020 but could not attend St Mary's without financial assistance. The scholarship has been made possible through the generosity of donors to the St Mary's Anglican Girls' School Foundation's Scholarship Fund and provides no less than 50% of tuition fees for the duration of the student's time at St Mary's.

The scholarship is open to girls who are Australian citizens or permanent residents and whose family can demonstrate that their financial circumstances prevent their daughter from attending St Mary's. Students are eligible for only one scholarship at St Mary's.

The scholarship is awarded on the basis of the student's academic results in the scholarship examination taken while in Year 6, 7, 8 or 9, the preceding two years' school reports, the family's financial circumstances and, if shortlisted, an interview.

It is the intention that the scholarship recipient will hold the scholarship for the duration of her schooling, unless her work or behaviour is not of the standard that is expected of all students at St Mary's, in which case the scholarship may be rescinded. The award does not cover boarding, the extra costs of some subjects, technology, text books and stationery, uniforms, musical instruments and tuition, camps and excursions and extracurricular activities. Eligibility

We welcome applications from girls

- who are an Australian citizen or holder of a permanent resident visa,
- who are entering Year 7, 8, 9 or 10 in 2020,
- who will make a positive contribution to the school, be eager to participate in the wide range of opportunities available at St Mary's and respect the School's values, and
- whose family can demonstrate that their financial circumstances prevent their daughter from attending St Mary's.

 - Statement of Financial Position. This information will be treated in the strictest confidence and sighted by the Principal and the Director of Finance and Administration and referenced by them in relation to this application.
 - Copies of the two most recent tax returns for all supporting parents.
 - A letter written by your daughter to the Principal, explaining why she would like to complete her education at St Mary's. She may like to describe some of the things she has achieved at school, activities that she participates in and how she would like to become involved at St Mary's.
 - Proof of your daughter's Australian Citizenship (eg birth certificate) or permanent residency (eg copy of visa).
 - Copies of your daughter's school reports for the preceding two years, copies of awards or certificates, and most recent NAPLAN results.
- attend testing at St Mary's on Saturday 18 May 2019.
 - if shortlisted, attend an interview with the Principal in June/July 2019.
